THESE HANDS-ON SCIENCE AND ENVIRONMENTAL EDUCATION PROGRAMS ARE DESIGNED TO COMPLEMENT THE SCHOOLS' SCIENCE CURRICULA AND CONNECT STUDENTS TO THE NATURAL WORLD IN THE CITY OF MILWAUKEE. PRESCHOOL, AFTER SCHOOL AND SUMMER CAMP PROGRAMS COMPLEMENT THE SCHOOL PROGRAM THROUGHOUT THE YEAR. OVER 32,000 CHILDREN WERE SERVED THROUGH THESE EDUCATIONAL PROGRAMS.
